Alabama	“Physicians with retirement waivers will be able to obtain emergency reinstatement of their licenses without completing the 25 credits of continuing medical education that would normally be required,” the statement reads. The temporary licenses will cost applicants nothing, and will be in effect until the statewide health emergency is over, according to the statement. Those who receive the temporary emergency licenses will also receive restricted Alabama Controlled Substances Certificates to treat only those suffering from and affected by COVID-19. Illinois	Gov. Pritzker issued a “call to action” for all former physicians, nurses, physicians’ assistants, nurse practitioners, and respiratory care specialists who have recently left the field for retirement or another reason to “come back and join the fight.”... the state will waive fees and expedite new licensure for all such personnel. Doctors who have had expired or inactive licenses for fewer than three years can temporarily restore their license. No fee or continuing education is required to work under the direction of Illinois Emergency Management Agency, the Illinois Department of Public Health or in a long-term care facility, hospital, or federally qualified health center, according to the release. North Carolina	Temporary and emergency rules approved by the Board would allow a physician or PA who inactivated his or her NC medical license within the past 24 months to quickly obtain a temporary license. Under the emergency rules, the physician or PA would be entitled to practice for whichever period is shorter: 90 days or 30 days from the point at which the state of emergency in North Carolina is declared over. If a licensee wishes to continue practicing beyond Dec. 31, 2020, the licensee will need to renew the active-unrestricted license and meet all current requirements at that time... Abbott directed the Texas Medical Board (TMB) and the Texas Board of Nursing (TBN) to fast-track the temporary licensing of out-of-state physicians, physician assistants, certain retired physicians, nurses, and other license types. Utah	If a healthcare professional's former Utah license to practice expired or lapsed while in good standing, the professional may obtain expedited licensure in their profession by submitting a regular application for renewal or reinstatement of licensure. Many other healthcare professionals who were formerly licensed in Utah or in another U.S. state or territory, whose license was unrestricted and in good standing, may apply for a volunteer health care practitioner license to work exclusively as a volunteer at a qualified location (clinic, hospital, church, etc.).
